



# Guidance Note – Infection Control

## What is this guidance about?

This guidance note provides information about infection control practices for activities undertaken on church premises and by Church Councils.

## Who does this guidance apply to?

This information is provided for use by Presbytery and Church Councils who decide to continue to undertake community activities.

Church Councils with non-church organisations renting or providing community services to vulnerable community members from congregation or presbytery facilities should use these guidelines as a tool to confirm the entity has appropriate protocols in place when deciding if the rental arrangement should continue.

Please note, other church entities who are authorised providers of community services using congregation facilities for this purpose have protocols they are required to follow.

#### Guidance

In light of the COVID-19 pandemic, leaders from all Presbyteries and Synod have provided strong recommendations to Presbyteries, Congregations and Faith Communities about worship and groups meeting on Uniting Church Facilities. Following the advice that has been provided by government health authorities, the priority is to:

- 1. Minimise the risk of exposure;
- 2. Reduce/slow down the spread; and

3. Mitigate the impact of the virus on both ourselves and the most vulnerable members of the community.

To lessen the risk to our communities, the following strategies are proposed to slow the rate of the spread of the virus:

- 1. Support Church Councils of Uniting Church congregations who have already decided to suspend worship in their congregation;
- Strongly urge that Church Councils of Uniting Church congregations immediately decide to suspend all worship services from 18 March 2020;
- 3. Strongly urge that Church Councils of all Uniting Church congregations
  - a. decide to suspend immediately all other church activities in their premises; and
  - b. decide to suspend immediately the use of their church facilities for all community users;
- 4. Noting that many church facilities are the base for community activities which are relied upon by the most vulnerable people in our communities (emergency relief, food banks, and the like), strongly urge that Church Councils in this situation adopt clear infection control protocols; and
- Should your Church Council determine that it can continue activities/services safely, please notify your Presbytery. We would also welcome you registering the activity <u>here</u>.

# Attachment 1 - COVID-19 Information Update dated 18 March 2020

## uniting church in Australia

People in leadership in the Uniting Church in the Synod of NSW.ACT

Leaders from all Presbyteries and the Synod have met today, to give consideration to the situation regarding worship and groups meeting on Uniting Church facilities. We have agreed to provide the following guidance to Presbyteries, Congregations and Faith Communities across the Synod.

We note the clear advice that has been provided by government health authorities, about the importance of acting early for the benefit of the whole society. Early action will minimise the likelihood of becoming infected, slow the rate at which the virus spreads, flatten the curve of the incidence of serious cases, and assist the medical and hospital systems in responding to seriously increased demands.

The very strong recommendation is that we should not be meeting in  $\ensuremath{\mathsf{person}}$  in any gathering.

As Paul long ago advised, "whenever we have an opportunity, let us work for the good of all, and especially for those of the family of faith" (Gal 6:10). Our commitment to the common good mandates that we proceed in this direction.

We have a responsibility towards one another in our community of faith. By keeping distant from one another, not touching physically, not gathering in groups, we lessen the possibility that we pass on the virus to one another.

We also have a responsibility to other people in our society. We know that the virus will keep on spreading. By not gathering, we reduce the spread of the virus in society, which flattens the curve, spreading out the number of serious cases, making it more feasible for the hospital and medical systems to cope with the inevitable rise of cases to be dealt with.

We acknowledge that conversations about modes of operating have been undertaken already in many presbyteries, congregations and faith communities. We anticipate that a government directive is imminent, which will restrict meeting in groups and require us to cease all gatherings.

We therefore propose the following strategies, on the understanding that they will contribute to lessening the risk, slowing the rate of spread of the virus in our communities.

- Support Church Councils of Uniting Church congregations who have already decided to suspend worship in their congregation;
- Strongly urge that Church Councils of Uniting Church congregations immediately decide to suspend all worship services as from today;

## Attachment 2 - Key Principles for infection control

If there is any concern regarding the capacity of the church, its members or volunteers to provide and/or continue an activity/service safely, the service/activity should be discontinued, until such time as reasonable controls can be determined and put in place.

Reasonable controls include:

- Protecting oneself from harm
- Practicing social distancing
- Cancelling mass gatherings of more than 100 people in an indoor setting or 500 people in an outdoor setting
- Protecting those at greatest risk of serious infection

#### Protecting yourself

The best way to protect yourself from COVID-19 is the same way you would protect yourself from catching flu or other respiratory illness:

- <u>clean your hands</u> for at least 20 seconds with soap and water or use an alcohol-based sanitiser with at least 60% alcohol.
- cover your sneeze or cough with your elbow or with tissue.
- avoid close contact with people who are ill
- avoid touching your eyes, nose and mouth
- stay home if you are sick.

## Practicing social distancing

#### What is social distancing?

Social distancing means we reduce the number of close physical and social contacts we have with one another.

When social distancing actions are combined with good personal hygiene measures the spread of a pandemic through the community can be slowed. This helps protect the most vulnerable members of the community and reduces the impact of the pandemic on essential, life-saving health services.

Social distancing is an effective measure, but it is recognised that it cannot be practiced in all situations and the aim is to generally reduce potential for transmission.

While practicing social distancing, people can travel to work (including public transport). For non-essential activities outside the workplace or attendance at schools, universities and childcare - social distancing includes:

- avoiding crowds and mass gatherings where it is difficult to keep the appropriate distance away from others
- avoiding small gatherings in enclosed spaces, for example family celebrations
- attempting to keep 1.5 metres between themselves and other people where possible, for example when they are out and about in public place.
- avoiding shaking hands, hugging, or kissing other people.
- avoiding visiting vulnerable people, such as those in aged care facilities or hospitals, infants, or people with compromised immune systems due to illness or medical treatment.

# Mass Gatherings: Public Health (COVID-19 Mass Gatherings) Order 2020

On 18 March 2020, NSW Health Minister Brad Hazzard made an Order under Section 7 of the Public Health Act 2010 to force the immediate cancellation of major events with more than 500 people.

The object of this Order is to deal with the public health risk of COVID-19 and its possible consequences by giving a Ministerial direction that prohibits mass gatherings of 500 or more people in outdoor spaces and 100 people or more in indoor spaces, subject to certain exclusions.

Section 10 of the Public Health Act 2010 creates an offence if an individual fails to comply with a direction with a maximum penalty of imprisonment for 6 months or a fine of up to \$11,000 (or both) plus a further \$5,500 fine each day the offence continues. Corporations that fail to comply with a direction are liable to a fine of \$55,000 and \$27,500 each day the offence continues.

## Who is most at risk?

People most at risk of getting COVID-19 coronavirus infections are those who have:

- recently returned from overseas, particularly from mainland China, Iran, Italy or Korea
- been in close contact with someone who has been diagnosed with COVID-19.

There is also evidence of limited spread of COVID-19 in the community in Australia. Based on what we know so far about COVID-19 and what we know about other coronaviruses, those at greatest risk of serious infection are:

• people aged 65 years and over

- Aboriginal people (as they have higher rates of chronic illness)
- people with chronic medical conditions, such as lung disease, heart disease, kidney disease, neurological conditions and diabetes
- people with impaired immune systems (such as people who have cancer or HIV, or who take high dose corticosteroids).

People living in group residential settings are at greater risk of being exposed to outbreaks of COVID-19 if a case is diagnosed in a resident or staff member. This includes:

- people living in residential aged care facilities and disability group homes
- people in detention facilities
- students in boarding schools
- people on cruise ships.

People living in some group residential settings are also more likely to have conditions that make them at greater risk of serious COVID-19 infection.

# What should I do if I come into contact with a person who has been identified as a contact?

If you have been in contact with a person identified as a close contact of another person with confirmed COVID-19 infection, you do not need to self-isolate (although the close contact does) and don't need take any other special precautions.

If a close contact develops symptoms and is confirmed as a COVID-19 case, public health authorities will determine who, if anyone, has been in close contact with them while they were infectious, and these people will be directed to self-isolate.

## **Additional Infection Control Practices**

In addition to the measures above additional infection control practices (subject to the specific context of each activity/service) should include consideration for:

- Provision for working from home.
- Updating contact details and distribution lists to ensure effective communication.
- Providing regular updates on arrangements and expectations with staff / volunteers / clients.
- Increasing the frequency of general cleaning regimes.
- Outsourcing of cleaning to professional cleaning service providers.
- Monitoring and securely storing supplies of tissues, hand sanitizer, toilet paper and Personal Protective Equipment.
- Use of highly visible hygiene protocol and etiquette posters <u>https://www.health.gov.au/news/health-alerts/novel-</u> <u>coronavirus-2019-ncov-health-alert/coronavirus-covid-19-</u> <u>resources</u>
- Making infection control a standing agenda item at all meetings and discuss concerns and precautions being-taken.
- Avoiding sharing of pens.
- Maximising space between people working/occupying an office / enclosed environment.
- Maintaining good ventilation.
- Using alcohol-based wipes and/or disinfectants to sanitise high traffic/high touch areas / artefacts (at least) twice-daily, e.g.:
  - Counters/benchtops/tables
  - Door handles and light switches

- Phones computers, computer mice and computer keyboards
- $\circ$  Bathrooms
- Spraying (high-use) furniture with Glen-20 (or similar) twice a day.
- Removing books, magazines and other public reading material from reception areas, except for program leaflets which people should be encouraged to take away.
- Providing additional bins to encourage people to use tissues and advocate the "catch it, bin it, kill it" strategy for those with coughs and sneezes.
- Removing water fountains
- Ensuring that those hiring your facilities/spaces are informed of any specific expectations and are aware of their own responsibilities regarding preventing exposure/spread, including restrictions on mass gatherings.
- Maintaining records of groups/persons hiring facilities/spaces for use.
